### STEPS TO APPLY

1. Complete the attached Community Membership application form in its entirety and return it to the Office Manager.
2. Obtain signatures from two sponsors (from different memberships). Sponsors must be current voting members of the Club (Active, Senior or Life Members) and in good standing.
3. Applicants should ask their sponsors to go over the bylaws, rules & regulations of the Club with them.
4. Sign the application. Please note that signature indicates compliance and confirmation of the statement on the form – “I have read the Bylaws, Rules & Regulations of the Deep Cove Yacht & Sport Club”.
5. Applicants will be contacted & interviewed by the Membership Director and a Past Commodore.
6. All applications will be reviewed by the Executive Committee before being accepted. Reviews typically take place once per month.
7. The Membership Director will contact applicants upon acceptance/decline of the membership application.

### DCYC BYLAWS PERTAINING TO THE COMMUNITY MEMBERSHIP

- Community member status may be granted, on a mandatory annual application basis, to any persons 19 years or older, and such members shall be entitled to:
  - Social privileges of the Club including the right to utilize the Club's Food & Bar Services
  - Attend Social Clubhouse functions
  - Rent the facility for events & functions
  - The right to be a member of Club committees
  - The ability to sign in up to 4 guests per day
- Community members shall NOT be entitled to:
  - **Parking on Club premises.** Parking is available in the local Deep Cove parking lots and street parking only
  - Vote in the general meetings
  - Hold a place on the Executive Office
  - Apply for or retain moorage or have use of the small boat facilities
  - Accrue seniority
  - Hold a Club key or Club Burgee
  - Have use of the Outstation or wharfs
  - Take advantage of any reciprocal moorage privileges
- Community memberships may include the applicant's spouse/partner, and/or children under the age of 19, as noted on the application form. Such named person(s) are referred to as “Family Members.”

### COMMUNITY MEMBERSHIP DUES

1. **Initial Membership dues:** Pro-rated from the date of membership acceptance until the end of the current calendar year.
2. **Annual dues:** \$200.00+GST billed on January 1 each year, once your membership has been approved to continue.
