



# Deep Cove Yacht & Sport Club

## APPLICATION FOR MEMBERSHIP

Thank you for your interest in joining the Deep Cove Yacht Club.

- Please complete the attached form (page 3) in its entirety and return it with applicable fee to the DCYC office.
- Please complete the attached Moorage Application Form (page 4) and submit with membership application form.
- Funds to be included are: Initiation fee, plus GST. Moorage payments should not be made at the time of application.
- Applicants must have two sponsors (from different memberships) sign their application. Sponsors must be current voting members of the Club (Active, Senior or Life Members). Applicants should ask one of their sponsors to go over the Bylaws and the Rules and Regulations of the Club with them.
- Applicants must sign their application and should note the statement on the form (i.e., I have read the Bylaws and Rules and Regulations of the Deep Cove Yacht & Sport Club...) their signature indicates compliance and confirmation of.
- Applicants will be interviewed by the Membership Director and a Past Commodore.
- All applications will be reviewed by the Executive Committee before being accepted. Reviews normally take place once per month.
- The **Membership Director** will contact the applicant upon acceptance.

### ACTIVE MEMBERSHIP- Dues (see table below)

Active members have complete membership in the Club. This includes:

- One vote per membership at a general meeting
- Moorage privileges on a seniority and availability basis
- The privilege of holding office
- A key to the Club, Wharves and Clubhouse
- Full use of the Clubhouse, Outstations, and Reciprocal Moorage

Membership priority is given to residents of the District & City of North Vancouver. Non-North Vancouver residents may be admitted at the discretion of the Executive.

An Active membership may include the applicant's spouse, partner, and/or children under the age of 19, as noted on the application form. Such named person(s) is referred to as a "Family Member."

### Active Member Dues:

The Initiation Fee is a one-time only payment and dues are paid annually. Annual dues are pro-rated from the date of acceptance for the year. The initiation fee is \$6,000 (less the applicable age discount, plus GST). The annual dues are \$950.00 (less the applicable age discount), plus GST.

### NON-RESIDENT MEMBERSHIP – Dues \$190.00

Non-resident membership is **available only to current members** who no longer live in the Lower Mainland  
Non-resident members:

- May retain the moorage seniority points acquired as an Active, Senior, or Life member
- May own and fly the Club burgee
- Shall not accrue moorage privileges, or use of the Outstation and club wharfs.
- Shall not vote at general meetings and shall not hold an Executive position
- Shall not retain keys to clubhouse or wharfs.
- Shall be required to reinstate his Active Member status upon return to the Lower Mainland and pay the differential in annual dues for the current year

### SOCIAL MEMBERSHIP- Dues \$380.00

Social membership is **available only to current Active members**. Social members:

- May have use of the Clubhouse
- May not retain moorage seniority that was attained while an Active member
- May have the option to return to Active membership
- May be a member of Club committees
- May not vote at general meetings
- May not hold an Executive position
- May not retain keys to the Clubhouse and wharves and may not own the Club burgee
- Have no moorage privileges and have no reciprocal moorage rights.

### SENIOR MEMBERSHIP- Dues \$475.00

Senior membership is **available only to current Active Members** who have been members for 25 years and are 65 years and older. Senior members have all the privileges and benefits of Active member status.

### FULL TIME STUDENT MEMBERSHIP – Dues \$100.00

Student membership is **available only to current members** who are full time students age 19-24. Members must provide proof of full-time school registration.

### SEMI-ANNUAL DUES PRO-RATED

Dues are payable from the month in which the member is accepted up to the end of the fee period as follows:  
January 1 – June 30 & July 1 – December 31

### VOLUNTEER WORK PROGRAM

The Deep Cove Yacht & Sport Club has always benefited from the use of time, energy, and expertise generously donated by its members. All Active, Senior and Social members are encouraged to donate volunteer hours throughout the year. A percentage of volunteer hours donated are credited off annual dues.

*This application is for membership only and that it does not guarantee moorage, even if you have applied for it. An application for moorage must be submitted with this membership application if you own a boat. Please note that if an applicant's main boat maximum length overall is greater than 44 ft then the application for membership cannot be accepted.*
